Structure of the After Care Program

The following structure is designed to meet the supervision guidelines of the Iowa Department of Human Services:

Age Groupings*	# of Students	Time/Days	Supervisors
3-year-olds to 1 st grade	30	3:30-5:30pm Monday – Friday; preschool students begin at 3:00pm) Note: 3-year-olds are only included during their school days of Mon/Wed/Thurs	Three
2 nd grade-6th grade //(OR age of 12) When a child turns 12, they transition to the Middle School after school program)	15	3:30 – 5:30 (Monday – Friday)	One

*Adjustments may be made at times to student groupings listed above so as to continue to meet DHS student/supervisor ratios while also supporting St. Mary’s School families; done at discretion of St. Mary’s Administration

Weekly Rates:

St. Mary’s After Care Program has a weekly rate as listed below. In order to be assured there is proper supervision, parents will be required to pay the weekly fee, even if your child does not attend for any reason. Drop-ins will not be allowed.

4 year old – 6th graders (under 12 years of age)

1 child: \$50.00
2 children: \$60.00
3 children: \$70.00

3 year old only:

1 child: \$30.00

Combination of 3 year old and 4 year old – 6th grade (under 12 years of age):

2 children: \$55.00
3 children: \$65.00

If at any time, you no longer need the services of the After Care Program, you may withdraw your child to avoid paying for weeks you do not need and can re-enroll if space permits. Because there are often other families on a waiting list, please let us know when you no longer need these services.

You will be charged weekly but billed on a monthly basis at the end of the month. If you become delinquent in your After Care Program billing, you will not be able to use this service.
